13. Antrim County Road Commission: Annual Drive Around – B. Thompson & D. Amos Estimates for Projected Projects for 2024: Chip/Seal

- Inwood Harbor: Chip/Seal Option \$39,000 or Cape/Seal Option 87,000
- Winters Rd.: Chip/Seal Option \$8,500 or Cape/Seal Option \$19,500
- Birch Pointe Dr.: \$8,000
- Timber Dr.: Seal cracks \$4,000

Amos mentioned that we need to wait and see what the State match is before we budget for these projects.

14. **Attorney's Report:** As reported. Derman also restated in his report that the deadline for connecting to the Cairn Hwy Sewer before the benefit charge of \$4,000 starts up is June 30, 2024. Everyone needs to get a sewer permit before they connect. This was advertised on November 24, 2022 that the sewer was completed and ready for connection and that beginning January1, 2023 properties have 18 months to make their connection.
