**RESOLUTION SETTING COST RECOVERY CHARGES FOR  
THE ELK RAPIDS FIRE DEPARTMENT COST RECOVERY ORDINANCE**

At a Regular Meeting of the Township Board, Township of Elk Rapids, County of Antrim, Michigan, held in the Township Hall on the 12<sup>th</sup> day of June, 2018, at 9:00 a.m. Eastern Daylight Time.

**WHEREAS**, the Township Board adopted Ordinance No. 2018-2 to provide for the fair and equitable recovery of Fire Department services, and

**WHEREAS**, the Fire Department has calculated the cost of an average response by the Department, and the costs associated with responses, which costs are currently paid entirely by the Township and its property owners/tax payers, and

**WHEREAS**, the costs to be recovered, as determined by the Fire Department, are found to be fair and reasonable and based on a fair apportionment to those benefiting from the Township's provision of services.

**NOW THEREFORE**, the Township Board of the Township of Elk Rapids, resolves as follows:

1. The Elk Rapids Fire Department Service Fee Schedule attached hereto as Appendix A is hereby adopted and shall be utilized in the recovery of Fire Protection Services, and/or other Service Response costs as provided in Ordinance No. 2018-2.
2. The Elk Rapids Fire Department shall have on hand the Service Fee Schedule, which shall be provided to those requesting it without undue delay and without cost.

Be it further resolved that all resolutions and parts of resolutions insofar as the same conflict with the provisions of this resolution shall be hereby rescinded.

Be it further resolved that the Service Fee Schedule established herein shall be effective thirty (30) days from the date of publication of this resolution.

Firefighter (in addition to those included above)	\$ 40.00 per hour
Investigate Burning Complaint	\$300.00 per hour
