5. **County Commissioner:** B. Hefferan: Update on the Antrim County Facade Project. Hefferan also talked about Miles for Memories-Help Home Personal ID Program: ID Bracelets with a QR Code to assist loved ones with Dementia or Autism return home safely.

**Sheriff:** Under Sheriff Hoch: Hoch talked about the drug and opioid problems in the County and that the issues are increasing; even in our township.

- 7. **Fire Department**: Chief Williamson: Report as presented. Williamson talked about taking training on car seat installation. A grant would pay for the class and he would be one of the few in the northern area who be qualified in this.
- 8. **Zoning Ordinance Amendment 2023-1:** This would amend Chapter 8, R-2 Residential-One Family and Two-Family Zone by adding Section 8.08, conversion of an existing Permitted or Special Exception Use. B. Derman The Planning Commission approved this resolution then sent it to the County. It was reviewed and passed by the County at a Special Meeting held June 6<sup>th</sup>, 2023.

9. **Letter of Support for the Village:** RAP 2.0 Funding for Ames Street Streetscape. **MOTION/S: Boisvert/Weber** to approve the letter of support. **MOTION APPROVED.** 

- 10. **Township Fixed Asset Capitalization Policy**: Auditors suggested that the Township increase our fixed asset capitalization policy from \$5,000 to \$10,000. **MOTION/S**: **Boisvert/Soper** to update the policy from \$5,000 and to \$10,000. Roll Call Vote: Weber, Amos, Boisvert, Hults and Soper all voting Yes, 0 No **MOTION APPROVED.**
- 11. **Antrim County Road Commission:** At a Special Township Board meeting held on May 24, 2023 the Board approved an estimated \$80,000 improvement at S. Bayshore Drive. Payment of \$60,000 is being made. There has been an addition to the project of 150ft of asphalt on the Village side to match up, at an estimated cost of \$7,000. The overall project should still come in at \$80,000 or less.

## 12. Township Sewer:

Roll Call Vote: Boisvert, Hults, Soper, Weber, and Amos all voting Yes, 0 No MOTION APPROVED.
- 13. Nakwema Trail: Holding Easements.

Discussion regarding any liability that may go along with easements for the trail and what stage the plans are at for the Township portion of the trail. Boisvert will contact Clark and Calcutt from the Nakwema Trail to set up a presentation for the Board to see where the project is at.

14. **Attorney's Report:** as reported:

Derman stated in his report that the deadline for connecting to the Cairn Hwy Sewer before the benefit charge of \$4,000 starts up is <u>June 30, 2024</u>. It was advertised on November 24, 2022 that the sewer was completed and ready for connection and that beginning January 1 2023 properties have 18 months to make their connection.
