- 7. **Fire Department:** Chief VanDenBerge: Report as presented. Requesting approval to hire Neil Harris. **MOTION/S: Szymanski/Hults** to approve hiring Neil Harris as recommended. **MOTION APPROVED.**

A. **Maple Harbor Sewer Project:** B. Muma provided a project update. They are at the punch list stage but the project is mostly completed.

Construction Bills: \$103,472.24.

- B. **Township Sewer Maintenance:** No maintenance this month on the existing sewer system.
- C. **Brady Letter: Grinder Pumps at Birch Lake:** Letter received from Pat and Carole Brady dated 6-28-18 regarding their purchase of grinder pumps. A response from Township attorney Matt Zimmerman was read at the meeting and sent to the Bradys stating that revenue from the purchase of grinder pumps from the Township goes into the fund for the sewer district.

- Hults stated that he compliments the County Road Commission for how nice the resurfacing of Townline Road turned out. The same was mentioned for roads in Inwood Harbor.
